

# TERMS AND CONDITIONS

## Runner Passport Competition

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Promotion commences at **5:00 pm (AEST)** on Friday 8 May 2026 and ends at **6:00PM (AEST)** on Monday 26 October 2026 (**Promotional Period**).
3. Entry is only open to residents of Australia aged 18 years or over (**Eligible Entrants**).
4. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. To enter, Eligible Entrants must:
  - a) Participate in **at least two (2) of the following EVA Air naming-right marathons**: Brisbane Marathon and/or Sunshine Coast Marathon and/or Taipei Marathon
  - b) Collect **2–3 stamps** on a runner passport from any of the marathons listed above, by either:

    - a. photo of your physical passport showing 2-3 the stamps collected, or
    - b. a PDF of your digital passport completed with 2 or 3 stamps

Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
7. Incomplete or indecipherable entries will be deemed invalid.
